

RESOLUTION NO. 757

A RESOLUTION OF THE CITY OF INDIAN HARBOUR BEACH, BREVARD COUNTY, FLORIDA; INCREASING FEES FOR PERMITS ISSUED PURSUANT TO THE FLORIDA BUILDING CODE; INCREASING FEES FOR SERVICES PROVIDED BY THE RECREATION DEPARTMENT; INCREASING FEES FOR THE REGISTERING AND RENEWING OF REGISTRATION OF VACATION RENTALS; PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council of Indian Harbour Beach, Brevard County, Florida, adopted the Florida Building Code to establish building regulations relating to building codes, all as provided in Article I of Chapter 6 of the Code of Ordinances; and

WHEREAS, the said code and other requirements of the said section of the Code of Ordinances provide for the issuance of specific permits by the City; and

WHEREAS, Section 6-2 of the Code of Ordinances provides that the City Council may establish fees for such permits and services by resolution duly adopted by the City Council; and

WHEREAS, the City Council established fees for specific Building permits in 2011 via Resolution No. 630; and

WHEREAS, the City Council of the City of Indian Harbour Beach determined the need to establish regulations and an inspection and registration process for Vacation Rental Properties within the city with the adoption of Ordinance No. 2018-05; and

WHEREAS, Ordinance No. 2018-05, Division B provides that the City Council may adopt fees, by way of resolution, for registering, renewing the registration annually, amending the named responsible party, the initial and annual inspection fees, and penalties for noncompliance; and

WHEREAS, the City Council established fees for vacation rental registration and re-registration in 2018 via Resolution No. 697; and

WHEREAS, the City of Indian Harbour Beach owns and operates five phenomenal municipal parks and maintains these parks in an exemplary manner and is authorized to establish fees, from time to time, for the use of such parks and associated park facilities; and

WHEREAS, the City Council established fees for specific Recreation services in 2022 via Resolution No. 731; and

WHEREAS, the City Council wishes to adopt this resolution in order to establish and provide for increases in said fees.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF INDIAN HARBOUR BEACH, BREVARD COUNTY, FLORIDA, that:
