

## RESOLUTION NO. 630

### A RESOLUTION OF THE CITY OF INDIAN HARBOUR BEACH, BREVARD COUNTY, FLORIDA ESTABLISHING FEES FOR PERMITS ISSUED PURSUANT TO THE FLORIDA BUILDING CODE; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City Council of Indian Harbour Beach, Brevard County, Florida has adopted the Florida Building Code in order to establish building regulations relating to building codes, all as provided in Article I of Chapter 6 of the Code of Ordinances; and

**WHEREAS**, the said code and other requirements of the said section of the Code of Ordinances provide for the issuance of certain permits by the City; and

**WHEREAS**, Section 6-2 of the Code of Ordinances provides that the City Council may establish fees for such permits and services by resolution duly adopted by the City Council; and

**WHEREAS**, the City Council wishes to adopt this resolution in order to establish and provide for the said fees.

**NOW THEREFORE** be it resolved by the City Council of the City of Indian Harbour Beach, Brevard County, Florida that:

**SECTION 1.** The following fees shall be charged by the City for building permits:

(a) Specific services and fees:

(c) New construction, alterations, remodeling, or any other work requiring a permit other than the specific permits listed above:

TOTAL VALUATION

FEE

\$1,000 and less

No fee unless inspection required, in which case a \$20.00 fee for each inspection shall be charged

\$1,000 to \$50,000

\$60.00 for the first \$1,000 plus \$5.00 for each additional thousand or fraction thereof, to and including \$50,000

\$50,000 to \$100,000

\$300.00 for the first \$50,000 plus \$4.00 for each additional thousand or fraction thereof, to and including \$100,000

\$100,000 to \$500,000

\$500.00 for the first \$100,000 plus \$3.00 for each

additional thousand or fraction thereof, to and including \$500,000

\$500,000 and up

\$1,760.00 for the first \$500,000 plus \$2.00 for each additional thousand or fraction thereof

(d) There will be a \$100.00 fee assessed to any uninspected or open expired permits

**SECTION 2.**      **PLAN CHECKING FEES.** When the valuation of the proposed construction exceeds \$1,000 and a plan is required to be submitted by Section 104.2 of the Florida Building Code, said plan checking fee shall be equal to one-half of the building permit fee as set forth in Section 104.7. Such plan checking fee is in addition to the building permit fee. **If changes to the approved plan are submitted**, then a plan re-review fee will be charged at a rate to be determined by the Building Official, not to exceed one-half of the original plan review fee.

**SECTION 3.**      **PENALTIES.** Where work for which a permit is required by this code is started or proceeded prior to obtaining said permit, the fees herein specified shall be doubled, but the payment of such double fee shall not relieve any persons from fully complying with the requirements of this code in the execution of the work nor from any other penalties prescribed herein.

**SECTION 4.**      This resolution shall take effect immediately upon its adoption.
